*Cavalier Club members (\$750-\$1,749) are eligible to request football reserved parking in the North I lot. All other reserved parking lots require a minimum gift at the Coaches Club level (\$1,750- \$3,499).

Football and Men's Basketball: Tickets and parking are based on availability. Season ticket and parking quantities are determined by Giving Level. Season ticket and parking locations and post-season ticket quantities are determined by Giving Level and/or Priority Points. Single-game seat locations are determined by Priority Points. Donors must have a current year Annual Fund gift to receive Priority Points. Additional Football season tickets may be purchased outside of donation-required areas. **Men's Basketball:** Premium, Prime, and Courtside seating eligibility is based on a John Paul Jones Arena gift as well as an Annual Fund gift and Priority Points. **Women's Basketball:** Tickets and parking are based on availability. New season ticket purchase and postseason seat location are based on Priority Points. Donors must have a current year Annual Fund gift to receive Priority Points. MEMBER BENEFITS

Members who donate \$100 or more to the Annual Fund can receive benefits based on their Giving Level. These benefits include: priority pre-sale, season, single-game, and post-season tickets, priority parking, priority seating options for some Olympic sports, local business discounts, a yearly membership packet, and subscription to *Cavalier Corner*. PRIORITY POINTS

Donors to the Annual Fund earn Priority Points which are calculated each year once Annual Fund pledges or payments are made. Priority Points are used when assigning season ticket seat location, parking location, single-game and post-season ticket quantities.
